1. Subject of the Agreement

HEIZHAUS offers dance and movement programs as part of its child and youth welfare services. This agreement governs participation in these programs at the HEIZHAUS dance studio in Leipzig.

Participation includes:

- All regular dance classes
- Open classes in the dance studio

The following are not included:

- External workshops
- Separately advertised projects

2. Registration

Participants are required to register for each class session via the Yolawo booking system on the HEIZHAUS website.

There are no additional costs for participants with a valid subscription.

3. Term

The contract begins on: _____

The minimum term runs until the end of the current quarter.

It is automatically renewed for three months unless it is terminated in a timely manner.

4. Termination

Termination is possible with **4 weeks** notice **at the end of the quarter**, in writing (email is sufficient).

The end of each quarter is:

- March 31
- June 30
- September 30
- December 31

The right to terminate the contract for cause remains unaffected.

5. Extraordinary Termination

Extraordinary termination is possible in particular in the event of:

- Illness
- Relocation
- Other serious reasons.

Proof may be required.

Termination takes effect at the end of the month.

6. Fees

Please check the box corresponding to your desired contribution level.

A description of the price tiers can be found in Appendix 1.

Combi EaP: €15 / month

Reduced: €32 / month

Regular: €40 / month

Soli: €48 / month

Participants are responsible for selecting their own price tier.

No proof of eligibility is required.

7. Payment Method

Payment is made monthly via SEPA direct debit on **the 5th of each month**. If the participant fails to make payment on time:

- Returned debit charges may be passed on.
- Participation may be temporarily suspended following a prior reminder
- HEIZHAUS reserves the right to take further action to collect outstanding debts

8. Adjustment of Fees and Contract Terms

HEIZHAUS is entitled to adjust fees and contract terms if there are objective reasons to do so (e.g., cost increases, structural changes). Changes will be communicated in writing at least **4 weeks in advance**.

A **special right of termination** applies as of the effective date in this case.

9. Course Offerings and Changes

Course offerings are continuously being developed.

HEIZHAUS reserves the right to:

- change, reschedule, or cancel courses
- offer new courses
- Change instructors.

There is no guarantee that a specific course will be offered, but rather a guarantee of access to the full range of courses.

10. Holidays and Cancellations

Courses are generally not held during school breaks or on public holidays.

Membership fees continue to be charged during this time.

In the event of cancellations, HEIZHAUS will make every effort to offer alternative sessions,

but there is no guarantee that such alternatives will be available.

11. Participation and Responsibility

Participation is at your own risk.

Participants are required to:

- disclose any health restrictions
- follow the course instructor's instructions

For minors:

Supervisory responsibility begins upon arrival in the classroom and ends at the conclusion of the course.

HEIZHAUS does not provide individual supervision outside of regular class activities.

The course instructor cannot guarantee that participants will be accompanied to the restroom or other adjacent rooms.

12. House Rules

HEIZHAUS reserves the right to temporarily or permanently exclude participants from its programs in the event of:

- repeated misconduct
- endangering others
- violations of the house rules

The current house rules are available on the HEIZHAUS website and form an integral part of this agreement.

13. Liability

HEIZHAUS is liable to the extent provided by law.

No liability is assumed for personal belongings.

Liability for damages resulting from slight negligence is excluded, provided that no material contractual obligations have been breached and no injury to life, limb, or health is involved.

14. Privacy

Personal data is processed solely for the purpose of fulfilling the contract.

This includes, in particular:

- Email communication
- Contact by telephone
- Information about courses, cancellations, and organizational changes

The processing is based on Article 6(1)(b) of the General Data Protection Regulation.

Data subjects have the right to:

- Access
- Rectification
- Erasure
- Restriction of processing

Further information is available upon request.

15. Photographs and Video Recordings

As part of our programs, photos and videos may be taken for documentation purposes (e.g., for funding agencies and internal reports).

These recordings are made based on HEIZHAUS's legitimate interest in documenting its own programs and activities.

Participants or their legal guardians may object to the taking of such recordings at any time.

Please inform HEIZHAUS as early as possible.

The publication of photos and videos (e.g., on the website, social media, or in public relations materials) will take place exclusively on the basis of separate consent.

16. Changes to Personal Data

You must report any changes to your address, bank account information, or contact information to HEIZHAUS immediately.

17. Severability Clause

If any part of this contract is found to be invalid, the rest of the contract will still be valid.

Description of Pricing Model

Our system relies on those who can afford to pay more doing so.

This means that people with less money can still take part in the dance classes. You can choose which price tier you fall into. We trust you to make a conscientious choice. We do not ask for proof of income and do not check your selection.

1. What does "reduced rate" mean?

As a general rule, reduced rates apply to children, recipients of public assistance, pensioners, students, and people with disabilities, as they often have limited financial resources.

Personal or structural circumstances - such as having fled their home countries or facing high healthcare costs - are also reasons why some people have limited funds available for recreational activities.

If this applies to you and you do not fit into any of the other price categories, please pay the reduced price.

2. What does "regular" mean?

If everyone paid the regular price, we would be able to cover all of our dance instructors' fees. Please pay this amount if you do not qualify for the reduced or solidarity rate.

3. What does "soli" mean?

People who pay the solidarity fee help cover the reduced rates, making it possible for those with less income to participate in our classes.

Do you manage to save money at the end of the month without having to check prices while shopping? If so, please contribute €2 per booking (single session) or €8 per month (subscription) so that others can join in the dancing too.

4. What does "Combi EaP" mean?

The Leipzig Education and Participation Package is available to children, adolescents, and young adults from families receiving basic income support, housing assistance, child supplements, social assistance (SGB XII), or benefits for asylum seekers.
